SHOW PROGRAM:

8:00 - 09:00 Vet check

9:30 - 14:30 Judgement, Breeding rights allowances

14:30 - 15:30 Preparation of prizes

15:30 - 16:00 Announcement of winners of all categories

16:00 - 17:00 Photoshoots/Cleaning after the show

The program is time-oriented and can be changed. Entry for visitors is allowed in time 10.00 – 15.30.

Price for visitors: for children over 3 years old, seniors 40 Kč, for adults 60 Kč.

Veterinary regulations :

- Other species than those exhibited or included in the program, are allowed to enter ONLY with agreement of organizers.
- The exhibitor is obliged to provide a veterinary certificate of the good health of his animals and to pass a veterinary inspection before the start of the exhibition(8.00- 9.00). The health certificate must not be older than 4 days and must be recorded in the hedgehog's health card or on a separate paper, which will be stamped.
- Each animal must be subjected to a medical examination before the start of the show.
- If there will be found any health inconvenience at examined hedgehog or there will not be any valid evidence of veterinary certificate – the animal can be / will be disqualified from the show and can be put into the quarantine.
- The disqualification can be done by vet, vet tech, judge or person who inspects animals during the veterinary check. In this case, there is no possibility of the starting/register fee refund.
- It is prohibited to present pregnant or lactating females.
- The minimum age allowed for animals is 3 months.It means, It is prohibited to register animals born on 24.11.2023 and later.
- There is no upper age border but please, take the animals health condition in mind.

In all APH categories, animals will be **judged according to the valid Standard** (Standard of Perfection IHA).

The LEH category will be assessed according to the APHDS standard.

Only the Judge and the owner of the animal can be present when judging animals.

Breeding rights allowances are possible on request. You can request them in the application form.

Disqualification during the assessment is possible due to very frightened or aggressive behavior, or if any conditions for exclusion are found during veterinary acceptance.

By registering and participating in the exhibition, the exhibitor agrees to the handling of the animal by the organizer and the judge.

By registering and participating in the exhibition, **the exhibitor agrees to the publication of his name and the name of his hedgehog** on the start list and on the results list.

By registering and participating in the exhibition, **the exhibitor gives consent to take photos and video recordings in the exhibition** premises and their subsequent publication on the APHDS website or on the official APHDS Facebook page.

SHOW CATEGORIES:

The exhibition categories will be determined according to the submitted applications. A total of up to 8 categories can be opened. In the case of a large number of hedgehogs in one category, it is possible to divide this category according to gender, age or other criteria.

Registered hedgehogs must have a pedigree or Birth certificate issued by an official organization dealing with the breeding of exotic hedgehogs.

PET CATEGORY WILL NOT BE OPEN!

For opening one category is needed participation of at least 6 animals from three different exhibitors. If there won't be sufficient quantity of animals, we have right to cancel this category or fuse it with another category. In each category will be three winning places.

During the show, you can find the non competing exhibition of Lesser Hedgehog Tenrecs and Longeared Hedgehogs.

Best in Show

The title is awarded to a hedgehog who has scored the full number of points (100b). If there are more such hedgehogs, the winner will be selected by all judges together. The judge may not vote for an animal with which the breeder or owner has a relationship. If no hedgehog has won 100b, then this award can be obtained by the hedgehog with the highest number of points.

Title Champion APH Database Slovakia

The title of Champion APHDS is awarded to a hedgehog who has achieved a point rating of at least 95 points (till Dec 31, 2022) or minimum 98,5pt (after Jan 1 st, 2023) at 2 shows organized by APHDS. To obtain this title, it is necessary that at least one evaluation is given in a personal assessment a physical exhibition organized by APHDS. This means that only 1 rating from online exhibitions is included in this title.

APHDS Multi Champion

The APHDS Multi Champion title will be awarded to an APHDS registrant hedgehog (not a hedgehog / breeder from other organizations) who obtains at least 95 points (till Dec 31, 2022) or min. 98,5pt (after Jan 1st, 2023) at 2 APHDS shows and at least 90 points at 2 shows abroad (outside the Slovak Republic) or organized by other associations than APHDS.

Application forms:

They will be available From November 15, 2023. Applications for the exhibition are available on the website APH Database Slovakia. Applications are submitted electronically using an online form.

One exhibitor can register a maximum of 5 APH hedgehogs, the number of LEH hedgehogs is not limited.

The application deadline will be December 28, 2023 at 8:00 p.m. Fees must be on the organizer's account no later than 3.1.202. After this deadline, no additional entries or changes in applications will be possible.

The number of exhibitors is limited. In the case of full capacity, the deadline will be moved to an earlier date. The organizers reserve the right to cancel/modify applications.

In the note for the recipient, write: EXHIBITION + your first and last name, otherwise it will not be possible to match the payment.

Your registration will be confirmed by email after receiving the payment. As soon as the exhibition is canceled by the organizer, the fees will be returned to the bank account from which they came.

Foreign exhibitors are allowed to pay the exhibition fee in cash upon entering the hall. It is NOT possible to pay cash in €!!!

Fees for International Hedgehog Show Běloutín 2024:

Entry fee for APH categories : 170Kč (7€) / hedgehog

Entry fee for LEH category : 110Kč (4€) / hedgehog

The sale of animals during the exhibition is not allowed, but it is possible to agree on the handing over of animals to new owner at the exhibition. All animals present in the hall must have a veterinary certificate of health and undergo a veterinary examination.

What to take with you?

- * Own exhibition bins.
- * Hygienic mat (diapers for puppies can be used) at least 40x40 cm
- * Health book or other record of the animal's health
- * Pedigree/ Birth Certificate of the animal
- * At your own decision, water and feed containers, food, snuggle bag.
